Who is qualified to apply?

Interested parties should be:

- Local company who must be a duly registered entity with the Registrar of Companies or with the Registrar of Business Names, in which a copy of the Incorporation Certificate or Registration Certificate is to be submitted along with the Names of Shareholders and Directors or Names of Proprietor/ Partners.
